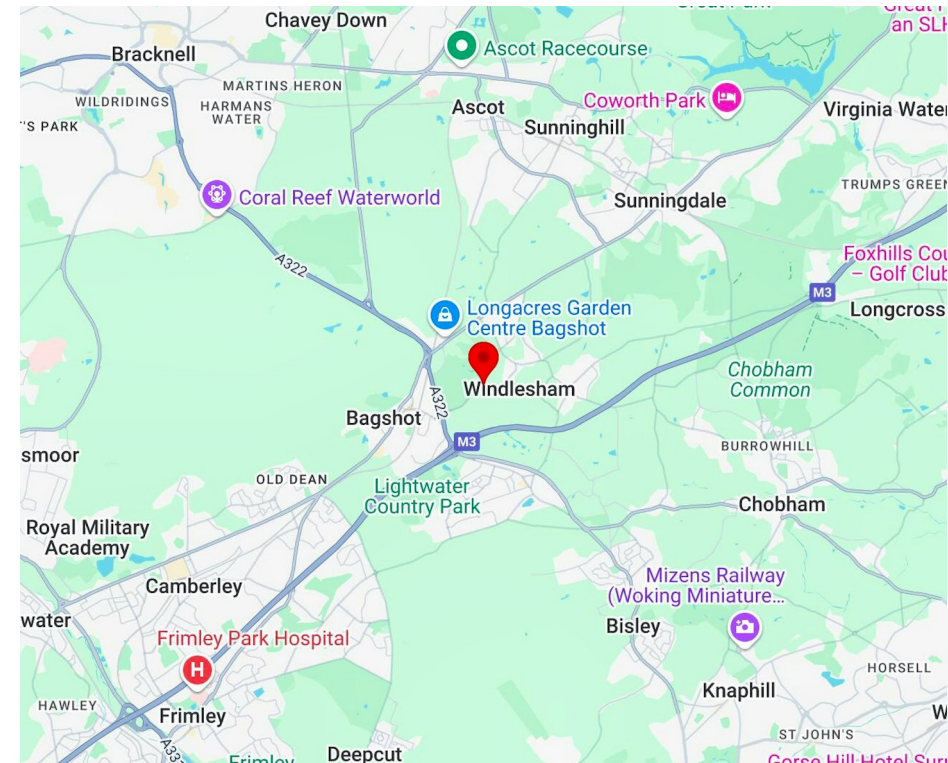
LOCATION

The site currently comprises a open storage yard with numerous occupiers including logistics and timber operators. There is a communal WC on site.

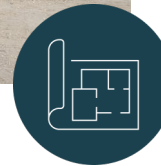
The site fronts New Road with a secure gated access. The open storage land is laid out over two levels with the main open storage area being to the west side of the site.

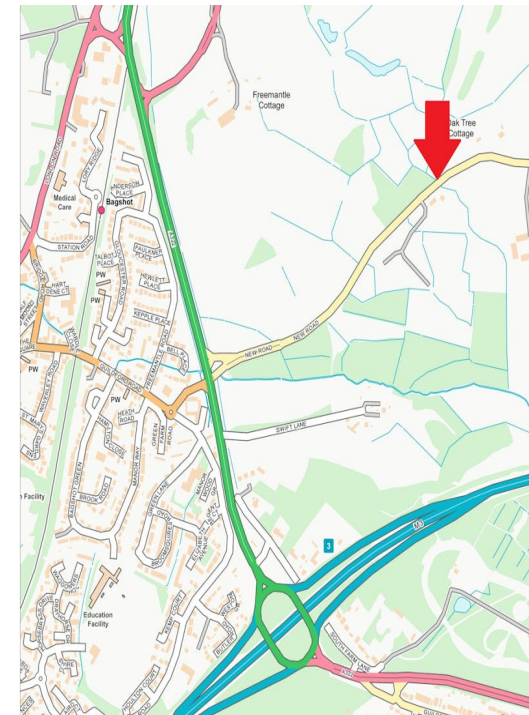

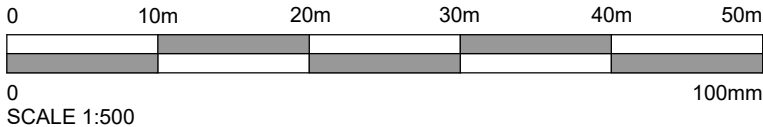
